

HOME ENERGY ASSISTANCE **SUPPORT**

Through federally-funded programs and partnerships with local power providers, LKLP was pleased to provide home energy assistance to those in need. Here is a breakdown of the support provided.

LIHEAP

LIHEAP is designed to provide income-eligible households with financial relief for heating and cooling costs at specific times throughout the year. This fiscal year, we were able to provide assistance the entire year through an expanded LIHEAP program offering totaling over \$4.6 million.

LIHWAP

Low Income Home Water Assistance Program (LIHWAP) was a new, temporary, federally-funded program added to complement LIHEAP. It provided qualified households with water and wastewater assistance. Through LIHWAP Subsidy, households could receive a one-time water service benefit ranging from \$50 to \$400 depending on income level, housing category, and water service benefit type. LIHWAP Crisis helped households experiencing a water and/or wastewater crisis with assistance for the minimum to alleviate the crisis not to exceed \$800.

POWER PARTNERSHIPS

LKLP is pleased to be the trusted partner of local power companies in their efforts to provide additional relief with home energy costs. Through programs like Home Energy Assistance (HEA), which is provided through American Electric Power Company and the HEART and THAW programs provided through Kentucky Power, we were able to help thousands of qualified residential customers offset home heating costs.

HEALTHIER AND SAFER HOMES

Once again, our handy team of weatherization laborers came to the rescue of many home owners in our region, saving them money and making their homes healthier and safer. This fiscal year, 50 homes were weatherized, which included making a variety of energy-saving repairs such as air sealing, duct sealing, insulation installation and more. These home improvements immediately improved the lives of the 200 men, women and children living in the weatherized residences. We ended the year with a waiting list, which will be first on our list for the next fiscal year.

HOUSING & WEATHERIZATION





A THREE-PRONGED APPROACH

LKLP's Workforce Innovation and Opportunity Act (WIOA) program spent its year focused on outreach, making connections and overcoming client challenges. With an emphasis in three core service areas - Youth Career Development, Adult Skills Training and Business Solutions, WIOA assisted more than 400 individuals and over 60 businesses in their pursuit to obtain or fill employment opportunities. Coming out of the pandemic created new and unique challenges, but the WIOA team went above and beyond to maximize its impact.

OPPORTUNITY YOUTH

We couldn't be more excited about our growing service offerings targeting young adults and disengaged youth. Helping young people overcome personal challenges and connect with employers through full-time employment and internships gives them a path to long-term career success. Through our Opportunity Youth program we were able to reach a younger demographic earlier, helping to shape their career path.

Opportunity Youth offers a community-based approach to provide essential life skills, work skills, training, career coaching and support services for young people ages 18-24. It targets those who have dropped out of school, or are out-of-school disengaged from the workforce and education system, involved in the criminal justice system, recovering from substance abuse disorder, experiencing homelessness, pregnant or parenting, aging out of foster care, or just need additional assistance to complete an educational program or obtain employment.

This year, Opportunity Youth assisted 157 young people with career counseling and education, paid job training and placement, tuition assistance, skill development and other supportive assistance to remove barriers to employment.

PROSPER APPALACHIA

Our partnership with Prosper Appalachia began last year and was a huge success. Working with area employers, we matched high school students with summer internships. Twelve-week paid internships gave students exposure to career fields, employment options, as well as connections for future full-time work opportunities. This year, we were able to match 35 students through the program.

ONEUP INTERNSHIP

Building on our partnership successes with local businesses, the LKLP WIOA team coordinated a OneUp Internship program, combining the needs of area employers and the career interests of participating students/graduates. Through the OneUp Internship, we were able to provide real world learning opportunities at a job site that could transition to full-time employment. Five participants received 480 hours of work experience at a rate of \$10.00 per hour last year.

MAKING CONNECTIONS

This past year our outreach efforts included job fairs and workshops, as well as one-on-one career services. We hosted personal finance workshops, interview skills training sessions and Facebook Lives to discuss a variety of workforce topics. All of our targeted outreach events had a clear purpose of raising awareness of our services and to make as many meaningful connections as possible. We found that with the help of WIOA and its workforce development partners, job seekers are better equipped to find and maintain long-term career growth and success. In all, 245 adults were provided training and specialized skills training, 143 people obtained employment with our assistance and 63 local employers utilized our services to fill available jobs.

FILLING THE HEALTHCARE GAP

An ever-growing demand for healthcare professionals. specifically nurses, was a top priority last year. We partnered with Appalachia Regional Hospital to address the nursing shortages in our area. Through the creation of an Externship, LKLP was able to provide 15 participants with hands-on experience in a healthcare setting, allowing them to explore various healthcare career paths. WIOA funding was used to reimburse a percentage of wages of each participant.

Thanks to a partnership with Galen College of Nursing and Appalachian Regional Healthcare, scholarships were another tool LKLP utilized to provide customized training opportunities to nursing students. Participants completed an interview process and were selected by college representatives and the employer. Those selected received up to \$7,000 of tuition assistance over a twoyear period. In return, scholarship recipients agreed to employment with ARH upon graduation. LKLP granted 20 ARH scholarships and 15 Galen scholarships last fiscal year.

AROUND TOWN

LKLP's Public Transportation services are a much-needed community resource for residents of Leslie, Knott, Letcher and Perry counties. This fiscal year, we logged 231,232 miles across our communities, shuttling individuals and families to destinations around town. In all, 14,662 trips were provided. Our safe and affordable transportation options made it possible for those without reliable transportation to carry out their daily routines and activities.

NON-EMERGENCY MEDICAL SERVICES

We're proud to be a longtime transportation provider for those who need assistance getting to and from important medical appointments. We know this service helps ensure our residents are able to access all of their healthcare needs. The number of non-emergency medical trips provided this year jumped by more than 25%, totaling 38,093. These trips also increased the number of miles dedicated to servicing our clients, reaching 629,888 in all. In addition to our immediate region, we were also able to ensure non-emergency medical services to people in seven additional Eastern Kentucky counties throughout Region 13. It wouldn't have been possible without our team of subcontractors, which are an incredibly important part of our program.

SMILING FACES

The highlight of our Head Start year was the return to inperson services. Without a doubt, seeing the smiling faces of our students made all the difference in our year. From classroom activities and playground fun to mealtime and naptime, our Head Start and Early Head Start centers were bursting with energy and excitement.

In all, 361 Head Start students and 130 Early Head Start students completed a successful academic year, culminating with end-of-year celebrations. Our classrooms were filled with educational activities that made learning fun. From participating in Reading Across America Week to visits from Dr. Seuss' Cat in the Hat, our teachers went above and beyond to make sure our students were engaged and progressing toward their goals.

We're pleased to report that 81% of all children met and/or exceeded widely held expectations in Mathematics according to Teaching Strategies Gold Assessment data. This was a 20% growth from the beginning of the year to the end.

COMMUNITY COLLABORATION FOR CHILDREN

STRENGTHENING FAMILIES

Community Collaboration for Children (CCC) routinely works with partners from across the region to help improve the lives of children and families. Our goal is to prevent child abuse and neglect by sharing resources that help educate and strengthen families. This fiscal year, CCC assisted 34 families, including 112 children, an increase over the previous year. We're happy to report that 100% of the families we worked with showed improvement according to our assessment tools.

A YEAR FOR PARTNERSHIPS

So much of our work stems from collaboration, starting with our Regional Network, which is comprised of nearly 70 members who meet bi-monthly. Leveraging one another's resources, knowledge and connections, the Network aims to raise awareness throughout the region to help minimize child abuse and neglect. We are grateful for their continued dedication to our cause.

CCC had the opportunity to participate in several fun community events this past year benefiting CCC families, including the following:

COMMUNITY BABY SHOWER

Held at Perry County Park, young families and expectant mothers received baby formula, diapers, children's clothes, car seats, strollers and other baby essentials. More than 90 families turned out for this fun event.



MATERNITY FAIR

Hosted by Primary Care at their clinic in Perry County, new parents and parents-to-be were able to gather lots of information about healthy pregnancies. Baby must-haves were also distributed to more than 200 families in attendance.



TOYS FOR TOTS

CCC families were the beneficiary of toys for the holidays thanks to the generous community donations given through Toys for Tots. This program has been a greatly appreciated resource for our families for the past three years. "Our goal is to prevent child abuse and neglect by sharing resources that help educate & strengthen families."





OUR PARENT SELF HELP IMPACT

LKLP's Parent Self-Help Education program was able to educate 247 families this past year through nurturing parenting classes, benefitting 521 children. Utilizing evidence-based curriculum designed to prevent child abuse, our classes taught parents how to use techniques and strategies that would help them become more nurturing to their children. Classes were made available online and in-person. We also conducted group classes at facilities such as jails, rehabilitation centers and drug court.

FATHERHOOD INITIATIVE

Thanks to a mini grant, Parent Self-Help Education was able to host a fatherhood-focused event at a local male rehab facility. Approximately 125 people attended this fun event,

which featured father/child activities, inflatables for families, a guest speaker and lots of good food. Everyone that was part of the event had a wonderful time.

BUILDING A BRIDGE

After completing parenting classes, several of our Parent Self-Help Education clients made the transition to be part of LKLP's CCC program. This transition allowed us to have a more personal relationship with families. Once a week, our staff would spend one-on-one time in their residence working on techniques such as appropriate discipline and daily routines. We also got to work with families to establish a safe and healthy environment for their children, as well as connect them to available resources in their community. Being able to work with families in both programs helps us better guide them toward becoming self-sufficient.



A SURGE IN CRISIS REPORTING

As the world rebounds from the pandemic, families and communities are reconnecting in ways they had not been able to do for quite some time. Because of this, there was a surge of crisis outreach within the community in fiscal year 2021-22. Families were able to more safely report abuse, making services like LKLP's Domestic Violence Program, Safe House and VOCA an increasingly vital resource.

LKLP's Safe House, which provides emergency shelter to those in imminent danger of domestic abuse, housed 69 individuals, including 28 children, 40 women and one male. Our Domestic Violence Program, which provides resources to individuals and families impacted by domestic violence, assisted 137 individuals, including 67 children, 70 women and one male survivor of domestic violence.

Our crisis hotline fielded 242 crisis calls, more than double from the previous year. Many shelters around the United States also reported an increase in crisis contacts and emergency calls this past year. This increase is attributed to the pandemic, and the isolation that many families endured while in quarantine.

IT TAKES A VILLAGE

We continued to work closely with the Rising Center. They have been a partner in our fight against domestic and interpersonal violence. They are able to provide supplemental counseling with our survivors. The Safe House has also been blessed with the continued assistance from local churches. First Baptist church provided our shelter residents with \$100 gift cards upon leaving the shelter to move into their own independent housing. They have also donated a significant amount of furniture and clothing to our residents. Our partnership with Project Rise also continued to great success. Many of our clients and residents were able to participate in group sobriety activities.

Perhaps a highlight event was our annual Shop and Share fundraiser. LKLP was pleased to host the statewide donation event at area grocery stores where shoppers were encouraged to donate much-needed supplies for the Safe House. Thanks to many community partners, our fundraiser was a huge success.






NAVIGATING THE CRIMINAL JUSTICE SYSTEM

NEW OUTREACH OPPORTUNITIES

VOCA staff were excited to connect with new partners this year, expanding our opportunities to make a difference in our communities. In all, more than 20 educational outreach events were held throughout the region. We were able to connect with the Kentucky River Regional Jail and Save the Children to develop an opportunity for incarcerated survivors in the recovery cells to receive free trauma therapy. Understanding that there is a significant correlation between substance misuse and adverse childhood experiences, we were all delighted to provide this positive step in their journey of sobriety.

Additionally, VOCA's and the Domestic Violence Program's participation in the Situation Table, hosted by the Perry County Quick Response Team (QRT) and the Primary Care Association was another highlight activity. The event facilitated a unique, risk-based, rapid triage model that brought together multiple human service providers to address acute elevated risk situations.

These new outreach opportunities are in addition to our established partnerships with organizations such as the Kentucky River Children's Advocacy Center, also known as the Care Cottage, AppalRED Legal Aid, Kentucky River Health Consortium, Eastern Streams Community Early Childhood Council, the Baby Pantry at New Hope Church, First Baptist Church and Summit Community Church to name a few.
